VENDOR SPACES

Vendors will be provided individual spaces based on individual needs of that vendor and space available. Space is free on a first come, first served basis. We do not provide shelter (tents, etc.) of any kind; our event is held rain (a distinct possibility in Oregon!) or shine.

CLEANING / DAMAGE DEPOSIT

We do not require a damage or cleaning deposit. We hope that those attending will remember that our host is providing the parking location for free and expects it to be clean when we leave. Our desire is to maintain a healthy, family friendly environment. Your assistance will allow us to invite you back next year!

INSURANCE

All vendors will be required to have and maintain documentation required by applicable State laws at all times on the premises, and agree to show such to persons asking for proof of insurance, health and other such documentation as required by law.

TATTOO & PIERCING VENDORS

All tattoo & piercing vendors providing services to our attendees must tell us on your application and must comply with all Oregon State laws in regards to the tattooing & piercing of minors. Any vendor found not complying with these laws will be closed down.

UNSUITABLE ITEMS

The Unions for Kids Committee reserves the right to, and at its sole discretion, cause any vendor or vendors to cease to sell or attempt to sell any item or items that in the opinion of the Committee or any of its members, appears to be offensive to the General Public or items illegal for sale in the state of Oregon

FEES

None at this time. Vendors agree to pay reasonable costs for clean-up and repair of any area damaged by them. Such items would be trash left behind, stains or damage to pavement, concrete and other damage resulting from carelessness. We believe the vendors we invite appreciate the opportunity and will act accordingly.

Vendors may begin set up from 5 p.m. to 9 p.m. (No guards, you may stay in lot in motor home, etc.)

Saturday, June 9, 2012

All Vendors must be set up no later than 8 a.m. We will be on site at 6:30 a.m.

Vendors must be completely vacated by 7 p.m. on June 11th.

VENDOR VEHICLE PARKING

Vendor vehicle parking areas will be designated and vehicles permitted at time of check-in. Vehicles parked in unauthorized areas will be subject to tow at owners' expense.

HOLD HARMLESS

Vendors agree to indemnify and hold harmless the Unions for Kids Committee, Doernbecher Foundation & Children's Hospital, OHSU, IBEW Local Union 48, its officers, agents and employees from any and all claims, causes of action and suits occurring or resulting from any damage, injury or loss to any person or persons, including but not limited to loss of property, goods, wares or merchandise, caused by, arising out of, or in any way connected with the exercise by the vendor of the privileges herein granted.
